**Communiqué of the Ministry of Foreign Affairs of the Islamic Republic of Iran on the
Condemnation of Large-Scale United States Aggression Against Iran in Gross Violation of
the Charter of the United Nations, International Law, and the Ceasefire of 8 April 2026**

Tehran, Iran- 11 June 2026

The Ministry of Foreign Affairs of the Islamic Republic of Iran condemns, in the strongest possible terms, the large-scale armed attacks and aggression perpetrated by the United States against the Islamic Republic of Iran, including attacks on vital infrastructure in the late hours of 10 June 2026, and stresses that full responsibility for the grave and far-reaching consequences of this reckless act of aggression rests squarely with the United States.

The unlawful and criminal attacks carried out by the United States in recent hours constitute a blatant violation of the Charter of the United Nations and the fundamental principles of international law, particularly those relating to the sovereignty and territorial integrity of States. Moreover, these actions have effectively rendered meaningless the ceasefire concluded on 8 April 2026.

Furthermore, the continued use by United States military forces of the territory and facilities of certain countries in the region to plan, support, and carry out acts of aggression against the Islamic Republic of Iran has effectively associated those countries with the perpetration of such unlawful acts. In this regard, the Islamic Republic of Iran strongly recalls the legal and moral obligation of all States to refrain from allowing their territory, facilities, or resources to be used for acts of aggression against Iran.

The Islamic Republic of Iran reaffirms its determination, in the exercise of its inherent right of self-defence in accordance with international law, to take all necessary measures to counter and neutralize the sources and origins of armed and aggressive attacks directed against its territory, sovereignty, and national security by the United States and its accomplices assisting or facilitating such aggression.

The Islamic Republic of Iran underscores the collective responsibility of all Member States of the United Nations to firmly and unequivocally condemn and oppose the flagrant violations of the Charter of the United Nations by the United States and the Israeli regime. Silence, inaction, or acquiescence in the face of such unlawful conduct, bullying, and lawlessness of the United States and the Israeli regime will only embolden further violations and accelerate the erosion of international law, driving the international order toward greater instability and insecurity.



The Islamic Republic of Iran also recalls the legal duty of the United Nations Security Council and each of its members to fulfill the Council's primary responsibility for the maintenance of international peace and security. It further underscores the legal and moral responsibility of the Secretary-General of the United Nations, before the conscience of humanity and international public opinion, to speak with clarity and candor regarding the realities on the ground.

Issuing vague and generalized statements at a time when the aggressive nature of the actions carried out by the United States and the Israeli regime is beyond any reasonable doubt cannot be considered a responsible course of action. Such an approach only serves to embolden the aggressors to persist in their lawlessness and to commit further violations of the fundamental principles and rules of the Charter of the United Nations and international law.
